Page xviii, Table of Contents, Appendix 3(E):

Indicate title of this appendix as “Names of Cases and Institutional Authors.”

Page 59, Rule 12.1:

In the gray component diagram, italicize “Case name” and in the Example, italicize “rev’d.”

Page 64, Rule 12.2(e)(2):

Replace first sentence with the following:

**12.2(e)(2) Abbreviated words in organization name**

Abbreviate words in an organization's name (apart from a person's name) that appear in **Appendix 3(E)**.

Page 81, Rule 12.6(b):

Replace last sentence with the following:

Identify the court, however, if citing the case in an issue of *United States Law Week* (“U.S.L.W.”), a looseleaf service that provided decisions of several different courts until it ceased publication in August 2018.

Page 83, Rule 12.6(c)(5):

Correct typographical error “court/ data” to “court/ date.”

Page 99, Rule 12.16(e):

Replace full citation example with “*State ex rel. Knotts v. Facemire*, No. 34647, 2009 W. Va. LEXIS 50 (June 5, 2009). Replace short citation example with “*Facemire*, 2009 W. Va. LEXIS 50, at \*19–20.”

Page 105, Fast Formats:

Change first example in the category “Statute in commercial database” to “Ariz. Rev. Stat. Ann. § 12-2604.A (Westlaw through 2d Reg. & 2d Spec. Sess. of 51st Leg.).”

Page 117, Rule 14.6(d), second paragraph:

Delete reference to “*United States Law Week* (“U.S.L.W.”),” a looseleaf service which ceased publication in August 2018.

Page 129, Rule 15.5(g)<sup>FN</sup>:

Indicate title of this rule as “Full citations to congressional hearings in academic footnotes.”

Page 187, Rule 19.5:

Replace URL for Part IV of the Oxford University Standard for Citation of Legal Authorities (OSCOLA):

Page 218, Rule 22.1(c):

In the gray component diagram, add an opening parenthesis before “[Edition number] ed.” and delete the opening parenthesis shown before “Year of publication.” Do not alter the closing parenthesis.

Page 278, Rule 31.1(a), Examples (Author’s name):

Put date parenthetical after name of website’s owner, as shown below:

Page 325, Rule 38.5(a), Example:

Replace the abbreviation “*Chi.*” with the word “*Chicago*” (in italics).

Page 346, Appendix 1(B), Federal Primary Sources, Court system and reporters:

Revise publication dates for United States Law Week to 1933–2018.
